

Brown Hill Keswick Creek Stormwater Board Excerpts from Board Members’ Registers of Interests

Under section 70(a1) of the *Local Government Act 1999*, the Subsidiary must publish on the website, in accordance with the regulations, the following details in relation to each Board Member as recorded in the Register of interests:
